What does KN95 Mean?

KN95 is China's equivalent to the United States N95 respirator standard. They both stop at least 95% of particles $>.3$ microns in size. A key difference is that KN95 masks often use the ear loop method of wearing a respirator whereas the N95 masks use two straps which can create a tighter fit. Neither respirator can function without a full seal, for that reason these masks can't be worn properly if the user has facial hair or stubble.

FDA and CDC Guidance on KN95 Respirators

On April 3rd 2020 the FDA issued a new Emergency Use Authorization (EUA) for importing non-NIOSH-approved respirators made in China, which makes KN95 respirators eligible for authorization if certain criteria are met, including evidence demonstrating that the respirator meets certain standards.

The FDA also issued guidance outlining a policy to help expand the availability of general use face masks for the greater public and respirators for health care professionals during this pandemic. The guidance applies to KN95 respirators as well. It explains that for the duration of the pandemic, when FDA-cleared or NIOSH-approved N95 respirators are not available, the FDA generally would not object to the importation and use of respirators without an EUA, including KN95 respirators. Although not required, if a KN95 respirator does not have an EUA, the FDA encourages importers to take the appropriate steps to verify the product's authenticity prior to importing.

The CDC has published guidance for optimizing the supply of N95 respirators. In the event of a shortage, there are seven different regions with product standards comparable to NIOSH N95. Two of the CDC accepted product classifications are KN95 from China and P2 from Europe. This product meets both of those standards.
